1. Introduction

Welcome to Earthdex FX. We are committed to protecting your personal information and your right to privacy. If you have any questions or concerns about our policy, or our practices with regards to your personal information, please contact us at support@earthdexfx.com

2. Information We Collect

We collect personal information that you voluntarily provide to us when you register on the Earthdex FX application, express an interest in obtaining information about us or our products and services, when you participate in activities on the Earthdex FX application or otherwise when you contact us.

The personal information that we collect depends on the context of your interactions with us and the Earthdex FX application, the choices you make, and the products and features you use. The personal information we collect may include the following:

- **Name and Contact Data.** We collect your first and last name, email address, postal address, phone number, and other similar contact data.
- **Credentials.** We collect passwords, password hints, and similar security information used for authentication and account access.
- **Payment Data.** We collect data necessary to process your payment if you make purchases, such as your payment instrument number (such as a credit card number), and the security code associated with your payment instrument.

3. How We Use Your Information

We use personal information collected via our Earthdex FX application for a variety of business purposes described below. We process your personal information for these purposes in reliance on our legitimate business interests, in order to enter into or perform a contract with you, with your consent, and/or for compliance with our legal obligations. We indicate the specific processing grounds we rely on next to each purpose listed below:

- **To facilitate account creation and the logon process.**

- **To manage user accounts.**
- **To enforce our terms, conditions, and policies.**
- **To respond to legal requests and prevent harm.**
